## **“THE GREATEST FOURTH IN THE NORTH” 28th ANNUAL CRAFT SHOW JULY, 3 & 4, 2018**

The Lake City Area Chamber of Commerce invites you to display and sell your homemade crafts during our “Greatest Fourth in the North” celebration. **The two day outdoor show will be held on Tuesday, July 3rd & Wednesday, July 4th.** The show will have very limited spaces located in the downtown area. We ask that you be open for business from 11 a.m. – 5 p.m., however you may choose to stay open later. **The fee for our two day show is \$50 for a 12’X12’ space to participate in.**

We do not allow you to work out of a motor home. If you wish to stay in your motor home, there is a full service park available four blocks away. You can contact Missaukee County Parks at 231-839-4945 or Maple Grove Park (10 blocks away) at (231) 839-4429 to make reservations. We recommend you do this as soon as possible, as these spaces go fast! Electricity will be available at the show. Restrooms and Porta-Johns will be available as well as dumpsters in a nearby location for your use.

You may set up the day of the show, but no earlier than 7 a.m. Each exhibitor will need to supply their own table, chairs, and we suggest, a canopy (if needed.) We will block off a few parking spaces in front of the area for you to utilize to unload and load only. You will be provided a parking map of where you may park after you have unloaded your merchandise.

This is a very busy time for Lake City, with many events over 6 days of celebration, including an ox roast, parade, children’s day, fireworks, nightly entertainment shows and more. This celebration brings approx. 25,000 people to Lake City and we hope the craft show will be another great success. I have been informed that there is an underground sprinkler system in the downtown Lake City Park located at 111 S. Front St. in Lake City, Michigan. The City of Lake City Ordinance Code, SECTION 90.41 of CHAPTER 90, states: "Use of staking in the Park shall be prohibited. Structures such as tents, stands, and trailers, etc. shall be held in place by a safe, weighted restraining system supplied by the vendor. Vendors unable to comply may not be allowed to set up in the area."

I agree to obey the City ordinance and use no stakes that may damage the sprinkler system. If I do not comply with the ordinance I understand that I will be charged with any damages incurred by me by the City of Lake City and I will be responsible to pay any and all repair charges and fines.
